

# RELEASE OF LIABILITY FOR MINORS

In exchange for participation in the Cannon Beach Escape Room organized by TAOPED, LLC ("The Cannon Beach Escape Room"), of 248 N. Spruce Street, Cannon Beach, Oregon, and/or use of the property, facilities and services of The Cannon Beach Escape Room, I agree for myself and (if applicable) for the members of my family, to the following:

1. I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by The Cannon Beach Escape Room, or the employees, representatives or agents of The Cannon Beach Escape Room.
2. I recognize that there are certain inherent risks associated with the above described activity and I assume full responsibility for personal injury to myself and (if applicable) my family members, and further release and discharge The Cannon Beach Escape Room for injury, loss or damage arising out of my or my family's use of or presence upon the facilities of The Cannon Beach Escape Room, whether caused by the fault of myself, my family, The Cannon Beach Escape Room or other third parties.
3. I agree to indemnify and defend The Cannon Beach Escape Room against all claims, causes of action, damages, judgments, costs or expenses, including attorney fees and other litigation costs, which may in any way arise from my or my family's use of or presence upon the facilities of The Cannon Beach Escape Room.
4. I agree to pay for all damages to the facilities of The Cannon Beach Escape Room caused by my or my family's negligent, reckless, or willful actions.
5. Any legal claim that may arise from participation in the above shall be resolved under Oregon law.
6. I agree that The Cannon Beach Escape Room, or the employees, representatives or agents of The Cannon Beach Escape Room, has the right to any photos or any video/sound footage of me during The Cannon Beach Escape Room event. These photos, video footage, and sound materials may be used for any marketing purposes.
7. I agree and acknowledge that I am under no pressure or duress to sign this Agreement and that I have been given a reasonable opportunity to review it before signing. I further agree and acknowledge that I am free to have my own legal counsel review this Agreement if I so desire. I further agree and acknowledge that The Cannon Beach Escape Room has offered to refund any fees I have paid to use its facilities if I choose not to sign this Agreement.

8. I, \_\_\_\_\_ (adult), consent to the participation of \_\_\_\_\_ (minor) in Escape Room Event, and agree on behalf of the above minor to all of the terms and conditions of this Agreement.

By signing this Release of Liability, I represent that I have legal authority over and custody of \_\_\_\_\_ (minor).

In the event of an injury to the above minor during the above described activities, I give my permission to The Cannon Beach Escape Room or to the employees, representatives or agents of The Cannon Beach Escape Room to arrange for all necessary medical treatment for which I shall be financially responsible. This temporary authority will remain in effect until terminated in writing by the undersigned or when the above described activities are completed. The Cannon Beach Escape Room shall have the following powers:

- The power to seek appropriate medical treatment or attention on behalf of my child as may be required by the circumstances, including without limitation, that of a licensed medical physician and/or a hospital;
- The power to authorize medical treatment or medical procedures in an emergency situation; and
- The power to make appropriate decisions regarding clothing, bodily nourishment and shelter.

10. The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. The Cannon Beach Escape Room has put in place preventative measures to reduce the spread of COVID-19; however, cannot guarantee that you will not become infected with COVID-19. By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk we may be exposed to or infected by COVID-19. I hereby release, covenant not to sue, discharge, and hold harmless the The Cannon Beach Escape Room, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.

I HAVE READ THIS DOCUMENT AND UNDERSTAND IT. I FURTHER UNDERSTAND THAT BY SIGNING THIS RELEASE, I VOLUNTARILY SURRENDER CERTAIN LEGAL RIGHTS.
